

ACKNOWLEDGMENT, STIPULATION, WAIVER AND RELEASE

In consideration of the opportunity to participate in auditions to become a Tennessee Titans cheerleader (hereafter the "Audition", which term shall include any preliminary practice sessions, observation sessions, workshop sessions and pre-audition clinics, as well as any and all preliminary auditions, semi-final auditions and final auditions, conducted by or under the auspices of Tennessee Titans Entertainment, Inc., wherever held, at any venue, including without limitation, at Baptist Sports Park, the Nashville Athletic Club and the Wildhorse Saloon), the Undersigned, for herself, any spouse, any insurers, her heirs, assigns, executors and administrators, hereby fully and finally releases, acquits and forever discharges Tennessee Titans Entertainment, Inc. doing business as the Tennessee Titans Cheerleaders ("TTE"), Tennessee Football, Inc. doing business as The Tennessee Titans ("TFI"), Seton Corporation doing business as Baptist Hospital, Baptist Health Care Affiliates, Inc., RPJ L.L.C. doing business as Nashville Athletic Club, Wildhorse Saloon, Inc., doing business as the Wildhorse Saloon, Cellular HQ, Inc., doing business as Sun Tan City, and all of their respective stockholders, members, managers, officers, directors, employees, agents, representatives, contractors, parent companies, subsidiaries, divisions, affiliates, insurers, predecessors, successors and assigns (collectively, the "Released Parties"), of and from any and all claims, demands, actions, causes of action, suits, costs, liabilities, damages, expenses or losses arising out of, related to or in any way connected with, directly or indirectly, the Undersigned's attendance at or participation in the Audition.

The Undersigned stipulates and agrees that she is aware of the level of physical exertion required for professional dancing, gymnastics and cheerleading and that she is further aware that participation in professional dancing, gymnastics and cheerleading, including the Audition, involves risk of physical injury, including serious injury, and that she is willing to assume these risks. Physical risks include, but are not limited to, broken bones, internal injuries, head injuries, eye injuries, spinal injuries, back injuries, muscle tears and strains, dislocations, subluxations, torn and strained ligaments, soreness, dehydration and physical exhaustion.

The Undersigned affirmatively represents that she (i) is over the age of eighteen (18) years, (ii) is capable of reading and understanding the English language, (iii) has read and understands this Acknowledgment, Stipulation, Waiver and Release and understands that if she is injured in the course of attendance at or participation in the Audition, she will be responsible for her own medical bills, treatment, injuries and damages, if any and (iv) is in good physical condition and knows of no medical or physical reason why she should not participate in the Audition. The Undersigned stipulates and acknowledges that but for the agreement to and execution of this Acknowledgment, Stipulation, Waiver and Release, the Undersigned would not be permitted to participate in the Audition. The Undersigned further acknowledges that

participation in the Audition does not guarantee that the Undersigned will be selected to be a Tennessee Titans cheerleader.

The Undersigned hereby consents and agrees that TTE and TFI may use the Undersigned's photograph, image, likeness, voice and name (in whatever form or medium) to publicize the Audition or to promote TTE or TFI.

This Acknowledgment, Stipulation, Waiver and Release applies to each and every Audition in which the Undersigned participates with TTE.
